- New bookings must be made between 10am (AEST) Thursday 10 October 2019 – 5pm (AEST) Wednesday 16 October 2019 (inclusive) in order to qualify for the offer.
- ~BOGOHO offer:
 - Eligible bookings will receive a discount of up to 50% off the 2nd passenger's cruise fare.
 - Offer is valid for new bookings on all Royal Caribbean International voyages departing between 10 October 2019 – 8 May 2021 (inclusive).
- #Family offer:
 - Guests booked as 3rd passenger and above will pay reduced fares from AUD \$19 per person per day.
 - Offer is valid for new bookings on all Royal Caribbean local voyages departing between 10 October 2019 – 21 April 2021 (inclusive).

If amending through Espresso the AUD/NZD \$100 change fee will be applied to the booking within 48 hours. There is no limit on the number of changes permitted to ship or sail date up to 151 days prior to sailing, however a separate change fee will be incurred for each request.
