Terms and Conditions of Sale:

- Offer applies to new individual bookings made between 10am (AEDT) Thursday 1 November 2018 and 5pm (AEDT) Wednesday 5 December 2018.
- Eligible bookings made on our BOGOHO non-refundable deposit program will receive a discount of up to 50% off the 2nd passenger's cruise fare, plus up to 25% off the 3rd and 4th passengers' cruise fares.
- Discount offer is valid on select Royal Caribbean International sailings departing after 1 November 2018. Please note: **Eligible sailing dates are subject to change and may vary through the promotional period**
- Eligible bookings made in a Balcony or Suite will receive a complimentary beverage package per person for local sailings 6 nights or longer only, departing between 1 November 2018 and 20 April 2020.
- Beverage package offer is valid on local sailings only - **Voyages must start or end in Australia. Voyages must be 6 nights or longer.**
- Beverage package offer is applicable to bookings made in a balcony stateroom or suite only during the promotional period. Bookings that are upgraded after the promotion ends will not be eligible for the complimentary beverage package offer.
- Beverage package provided will be our Deluxe package for guests over 18 years of age (valued at up to USD \$70 per person per day), and the Refreshment package for guests under 18 (valued at up to USD \$29 per person per day).

- Offer will only be applicable to groups at the individual booking level. Offer cannot be held in conjunction with unnamed space and not available for Group Standard price.

- For bookings made on our non-refundable fare, please ensure that promotion names '**BOGOHO NRD**' and '**BEV NRD**' are listed in the reservation at time of booking.
- The Deluxe beverage package includes: wines by the glass, cocktails, spirits, liqueurs and beer (all up to USD \$12 value).
- Both the Deluxe and Refreshment (non-alcoholic) beverage packages include: bottled still and sparkling water, fresh squeezed juices, non-alcoholic cocktails, premium coffees and teas, fountain sodas, Coca-Cola Freestyle® beverages, Coca-Cola® souvenir cup included.
- Beverage packages are non-transferrable and not redeemable for cash. Guests must comply with the ships' terms & conditions of use.
- Dates of birth for all guests must be provided at the time of booking otherwise the Deluxe beverage package cannot be applied. This is a legal requirement and we reserve the right to withdraw the package if guests do not meet the minimum age on embarkation day. The minimum drinking age for all alcoholic beverages on Royal Caribbean ships sailing from Australia and New Zealand is 18. The Refreshment package will be automatically applied to all guests under the minimum drinking age on embarkation day.
- The beverage packages will be added within 72 hours of booking creation, and will be added to the booking as a cost and a corresponding reduction.
- A limited number of staterooms are available at the prices shown, once these staterooms are sold out, prices may be increased, or withdrawn or further reduced without notice.
- Any eligible booking that is cancelled and then reinstated after 5pm (AEDT) Wednesday 5 December 2018 will no longer be eligible for the promotion. Any booking that is modified after the promotion has ended will result in the loss of the promotion. Examples of changes that will result in the promotion being forfeited include, but are not limited to; change of ship, sail date, category booked, amending the travel agency ID or selecting an alternate price/promotion.
- Any booking created and deposited as a non-refundable fare will maintain this status for the life of the reservation, regardless of subsequent fare changes. Non-refundable deposit booking cancelled prior to sailing will be subject to cancellation charges from time of booking.
- Eligible Non-refundable deposit bookings made six months or prior to departure date will also receive up to US \$100 onboard credit per stateroom, displayed as "*OBC NRD*". Onboard Credit (OBC) is per stateroom and varies by category and length of sailing; **1. Sailings 5 nights or less:** Interior & Oceanview: US\$ 25 per stateroom; Balcony & Suite: US\$ 50 per stateroom; **2. Sailings 6 nights or longer:** Interior & Oceanview: US\$ 50 per stateroom; Balcony & Suite: US\$ 100 per stateroom.
- Any booking made on a non-refundable deposit fare will attract a fee of AUD/NZD \$100 per person for any changes to ship or sail date only. Ship or sail date can be amended through Espresso or our Reservations Team. If amending through Espresso the AUD/NZD \$100 change fee will be applied to the booking within 48 hours. There is no limit on the number of changes permitted to ship or sail date up to 151 days prior to sailing, however a separate change fee will be incurred for each request.
